I am the chairman for the Omanuka Trust, Nuhiti L block. Nuhiti Road, Anaura Bay

The walkway being given permission to go ahead.

The reasons for making my submission are (briefly describe the reasons for your views:

We have had nil communication from the Trustees regarding access over our land, yet the proposed trail passed right through our land and in close proximity to areas we use for our beneficiaries recreation and the trail will result in a loss of privacy, and loss of enjoyment to our beneficiaries. The Trustees have appeared to created a great spin and spent large amounts on an information booklet and publicity in which they state they have "undertaken extensive engagement since 2021 with as many effected land owners", yet we have had no communication at all.

- Â٠ We have concerns over the environmental effects of increased traffic, and users of the trail and the unrestricted ability of those users to stray onto our private land and cause damage to native plantings, trees, the foreshore and land.
- Â٠ We have concerns over liability of health and safety issues of the trail users who are on the road and also our land. Again we have had no communication from the trustees and this in not covered in the trail information. The proposal seems to assume the users will share a narrow gravel road with vehicles with no issues at all.
- Â٠ We have concerns over rubbish disposal and toilet facilities. Again we have had no communication from the trustees and this in not covered in the trail information.
- We have concerns over the safety of our beneficiaries and the security of their assets, due to increase numbers of people using the proposed trail and passing in close proximity to our beneficiaries and their families.
- Â٠ We have concerns over increased vehicle movements both on the narrow one-way gravel road and across our private land. We have concerns over vehicle parking options.

The reasons for making my submission are (briefly describe the reasons for your views:

## Infrastructure & Environmental Impacts

There is inadequate infrastructure for the intended influx of visitors. Public roads are in need of repair, and hardly suited to an influx of visitor traffic. There are safety risks and concerns in terms for cyclists and pedestrians in terms of isolation, being near hunting grounds, connectivity or lack of and response time for emergency services. This influx could put a huge strain on the medical volunteers in these areas. What is the liability for injured cyclists or pedestrians crossing private owned land, who will take accountability? Increased traffic is most likely to bring harm and pollution to pristine coastlines. Given there are plenty of existing cycle trails, I do not see the need to tamper with the pristine forests and coastlines. The impact to the environment is harmful in that it attracts unwanted development and change

## Legal Rights of the Applicant

Te Ara Tipuna Charitable Trust, as non-owners of our whenua (Ohinepoutea B, Matarau B2, Mangawhariki 7C2, Tokaroa A1, Kokai A3C, Herupaara A2A, Taumataotewhatui, Tikapa A8, Tikitiki B2B, Tikitiki x nos 1 & 2, Tikitiki x7, x8, x11, x12, x13, x15 and Makahikatoa, Whetumatarau B20, Whetumatarau B22, Tapuaeroa C, Tapatu A1, Ngawhakatutu A11A2, Ngamoe A4B5, Matarau L9, Marangairoa B2, Mangawhariki No. 2C, Mangawhariki 3E, Mangawhariki No 2A, Kohukohupaua 2, Te Araroa Maori Township (multiple blocks), Hinetiraha A7, Tikitiki D8,)does not have the legal right to submit a resource consent application to construct, operate, and maintain a recreational pathway on our land without consulting us and obtaining our consent.

Under New Zealand law, the ability for a non-owner to apply for resource consent to build on MÄ ori land is subject to specific legal requirements, primarily governed by the Resource Management Act 1991 (RMA) and Te Ture Whenua MÄ ori Act 1993.

## Authority to Apply

A non-owner cannot legally apply for resource consent for a project on MÄ ori land without the explicit approval or authorization of the landowners or governing trustees. Any proposed development must have the consent of those with decision-making authority over the land.

## Right to Object

As a beneficiary of Ohinepoutea B, Matarau B2, Mangawhariki 7C2, Tokaroa A1, Kokai A3C, Herupaara A2A, Taumataotewhatui, Tikapa A8, Tikitiki B2B, Tikitiki x nos 1 & 2, Tikitiki x7, x8, x11, x12, x13, x15 and Makahikatoa, the landblocks I have found on the Te Ara Tipuna map which appear to be directly impacted by this proposal but not withstanding all blocks listed above, I am exercising my legal rights under the RMA and Te Ture Whenua MÄ ori Act 1993 to declare this application invalid. Further, that this application is unlawful. I know of one whanau member who has been made aware of this project and that is coming from Te Whanau Apanui and not Ngati Porou, so given the owners and contact details are recorded, how can it be, that no one in my extended whanau has been consulted in regards to the lands in which we are shareholders and beneficiaries in Ngati Porou. We have definitely not granted consent for this project. Our decision-making authority over our whenua has been disregarded, as we suspect is the case for many other landowners affected by this project. We have social media to thank for learning about this kaupapa. Furthermore, it was a challenging and lengthy process to find our land blocks directly impacted by this proposal. Would they not be individually listed as part of the project application for greater transparency?









While legal redress is available to us, this is an unnecessary and unfair burden given that the RMA is designed to protect landowners and ensure their sovereignty (tino rangatiratanga) over their whenua.

The RMA clearly emphasizes the need for consultation with affected parties, including MÄ ori landowners, in matters involving MÄ ori land. The failure to appropriately consult us as landowners undermines the integrity of this application and exposes it to legal challenge.

Formal Objection to Resource Consent Application LU-2020-112074 by Te Ara Tipuna Charitable Trust entering Tuparoa.

The reasons for making my submission are (briefly describe the reasons for your views:

Our objection is based on the following key points:

## 1. Legal Rights of the Applicant

We contend that Te Ara Tipuna Charitable Trust, as non-owners of our whenua Rahui A8, does not have the legal right to submit a resource consent application to construct, operate, and maintain a recreational pathway on our land without consulting us and obtaining our consent.

Under New Zealand law, the ability for a non-owner to apply for resource consent to build on MÄ ori land is subject to specific legal requirements, primarily governed by the Resource Management Act 1991 (RMA) and Te Ture Whenua MÄ ori Act 1993.

#### Authority to Apply

A non-owner cannot legally apply for resource consent for a project on MÄ ori land without the explicit approval or authorization of the landowners or governing trustees. Any proposed development must have the consent of those with decision-making authority over the land.

#### Right to Object

As landowners and beneficial owners of Rahui A8, we are exercising our legal rights under the RMA and Te Ture Whenua MÄ ori Act 1993 to declare this application invalid. We assert that this application is unlawful as we were not consulted, nor did we grant consent for this project. Our decision-making authority over our whenua has been disregarded, as we suspect is the case for many other landowners affected by this project.

While we recognize that legal redress is available to us, this is an unnecessary and unfair burden given that the RMA is designed to protect landowners and ensure their sovereignty (tino rangatiratanga) over their whenua.

The RMA clearly emphasizes the need for consultation with affected parties, including MÄ ori landowners, in matters involving MÄ ori land. The failure to appropriately consult us as landowners undermines the integrity of this application and exposes it to legal challenge.

I wish the Commissioner Panel to make the following decision (give details, including the nature of any conditions sought):

We request that this application be reconsidered and rejected on the grounds that it fails to meet the legal and consultation requirements outlined above. As Rahui A8 Ahu Whenua Trust, our committee does not support this trial coming through Tuparoa and support all submissions from our Tuparoa whanau.

## 1. Legal Rights of the Applicant

We contend that Te Ara Tipuna Charitable Trust, as non-owners of our whenua Reporua A3C, A2B3A, A2B3B, A2B3D1, A2B3D2, Reporua B does not have the legal right to submit a resource consent application to construct, operate, and maintain a recreational pathway on our land without consulting us and obtaining our consent.

Under New Zealand law, the ability for a non-owner to apply for resource consent to build on MÄ ori land is subject to specific legal requirements, primarily governed by the Resource Management Act 1991 (RMA) and Te Ture Whenua MÄ ori Act 1993.

### Authority to Apply

A non-owner cannot legally apply for resource consent for a project on MÄ ori land without the explicit approval or authorization of the landowners or governing trustees. Any proposed development must have the consent of those with decision-making authority over the land.

#### Right to Object

As landowners and beneficial owners of Reporua A3C, A2B3A, A2B3B, A2B3D1, A2B3D2, Reporua B, we are exercising our legal rights under the RMA and Te Ture

Torere 42 Block oppose the application for the Te Ara Tipuna Trail as it pertains to the involvement of Torere 42 Block. We also support the opposition of our neighbouring whenua, Torere 41 Block while also noting that their block is more greatly affected than our own. In addition, we support our iw Ngai Tai in opposing the Te Ara Tupuna Trail and we will not support or endorse this application as it currently stands. We acknowledge only a small part of our block is proposed for the trail, however it is important to support the opposition of others within our iwi due to our close whakapapa connections.

## The reasons for making my submission are (briefly describe the reasons for your views:

### 1. Lack of consultation and communication

In support of our whanau from Torere 41 Block, there was no previous approach to consult with us as affected landowners, and a total disregard for the importance of a tikanga process that would have necessitated a face to face hui with the iwi and trustees. We have been informed by our iwi authority that an approach was made to them to conduct consultation with Ngai Tai land owners themselves, despite them being under-resourced, under staffed and with other priorities including being mid-way through a settlement process. This initiative is from Te Ara Tipuna. You should have conducted the consultation with land owners and not have expected our iwi authority to do it. As a result, the first contact we have had regarding this proposal was from the Opotiki District Council with no previous attempt to meet with us personally. The lacklustre communication process has clouded our opinion of the possible merits of such a project.

We find it surprising that the website has been live for 18 months yet landowners were only given two months to provide feedback over the summer period when whanau are pre-occupied with christmas and summer holidays for at least a month of this. If this was such an important kaupapa you would have given landowners an appropriate timeframe to hui together and feedback.

We support the position that our Ngai Tai Iwi Authority have taken in that there will be no support or endorsement of the Te Ara Tupuna track until you meet face to face with land owners and even then it is improbable that support will be forthcoming because of other reasons which will be revealed below. We are disappointed at the way you have gone about obtaining this consent. We were here, you just had to make contact yourselves.

## 2. Economically unviable

Despite claims to the contrary, we do not see an economic benefit from the Te Ara Tipuna Track. The block is already utilised with a macadaemia, banana and tamarillo orchard and we are in the process of establishing housing options. We do not need a track to traverse our block at the moment as it is already an economically producing block for the collective advantage of our owners.

The position of our block means hikers are unlikely to stay overnight. Opape Motor camp and Corals B and B are very close and there are other options within the Ngai Tai rohe. We are also less than a days walk from the end of the track. There would be little possibility of economic benefit in that sense.

#### 3. Whenua utilisation

We have already mentioned the utilisation of our whenua. Creating an easement on the whenua for a track and/or camping area is not in our strategic interest as land owners.

Further up the roadway from the proposed track lives our 93 year old papa. We would not want him to be pestered by people who may want to borrow his toilet, front yard for a tent, or anything else. This may create anxieties and safety issues for him and certainly for us.







We have concerns over rubbish and/or toileting that may be left on the track and note the expectation is for land owners to maintain their own part of the track. We have no-one currently living on the land that could regularly undertake these tasks. We do not support strangers walking all over our whenua. Who takes responsibility should an accident happen? Who takes responsibility for those who may stray off the track and down to the nearby beach? We have worked hard to ensure this area is accessible to whanau and our iwi, not to anyone. The beach has rips and no cell phone coverage. In the past when strangers accessed this beach, they have left large amounts of rubbish and it was difficult to provide any support to accidents that have occurred. We have every right to protect our whenua for our shareholders and more importantly our iwi.

#### 4. Whenua MÄ ori

As we all know, iwi have lost almost all the whenua we used to exercise kaitiakitanga over through colonisation. We only have very small parcels left with often large numbers of shareholders. In maintaining our autonomy and exercising the right to manage these small land block parcels, our priority will always be to develop and manage the whenua for the benefit of our shareholders and the wider iwi. It is not to create an easement for an uneconomic project that will see no benefit to our whenua and shareholders. We also will not be agreeing to parting with the amount of land needed to create an easement that we can not easily undo for future generations.

Based on the Te Ara Tipuna Trail Alignment as per Gisborne District Council's interactive map, I oppose consent being given for the proposed trail way having assess to Pa Road Whangara and its surrounding beaches and environments up to the boundary holding the manawhenua/manamoana of Hauiti.

### The reasons for making my submission are (briefly describe the reasons for your views:

- Around 33% of the homes in the Whangara Beach community have dual frontages one on Pa Road and another on the private road leading to Whangara Marae. Approximately 56% of homes have access to both the private road and the beach. The proposed trail would:
- a) Pose safety concerns for our community, particularly for those living alone, kaumatua, and tamariki.
- b) Disrupt the peaceful environment that our residents value and are entitled to enjoy.
- c) Increase congestion and place additional strain on the maintenance of Pa Road, the private road, and the beach. This could lead to higher costs for road and beach upkeep, which would likely fall to the community residents. Nothwithstanding the disruption maintenance work incurs, these costs may include more time from the community to maintain public access points, as well as potential hikes in taxes and/or rates. Whangara Beach is a small rural community with predominantly low-income families and elderly residents. We don't have access to many urban amenities to local authority services such as water, sewage, and rubbish collection, and we cannot afford, nor will we welcome increases in taxes to accommodate outside interests.
- d) There is no space for safe roadside parking, this will lead to parking issues. Both Pa Road and the private road are narrower than typical residential streets, making parking unfeasible.
- e) Create safety hazards for tamariki who use the private road.
- f) NgÅ ti Konohi has already granted significant public access to its turangawaewae through the establishment of the Te Tapuwae o Rongokako Marine Reserve. This should be sufficient however, the concept of Te Ara Tupuna Trail carries undertones that implies another method of reducing the manawhenua of local iwi and hapu by stealth.
- g) The consent process undermines the mana of NgÄ ti Konohi iwi. Decisions about the proposed trail are being made primarily by landowners, which could exclude iwi and hapu voice. This raises concerns about whether the process creates barriers to local iwi/hapu to exercise its manawhenua in this matter, given the iwi's origins pre-date current landowners.
- Threaten to disrupt and damage the fragile ecosystem of Whangara Beach, home to endangered species such as the Tuturiwhatu (Dotterel), along with other seabirds and insects.

I am writing to formally object to the above-mentioned resource consent application submitted by Te Ara Tipuna Charitable Trust (LU-2020-112074) to construct, operate, and maintain a recreational pathway, â€<sup>-</sup>Te Ara Tipuna,' around TairÄ whiti from Gisborne to ÅŒpÅ tiki. My objection is based on the following key points:

### 1. Legal Rights of the Applicant

I contend that Te Ara Tipuna Charitable Trust, as non-owners of our whenua, and does not have the legal right to submit a resource consent application to construct, operate, and maintain a recreational pathway on our land without consulting us and obtaining our consent.

Under New Zealand law, the ability for a non-owner to apply for resource consent to build on MÄ ori land is subject to specific legal requirements, primarily governed by the Resource Management Act 1991 (RMA) and Te Ture Whenua MÄ ori Act 1993.

Authority to Apply

A non-owner cannot legally apply for resource consent for a project on MÄ ori land without the explicit approval or authorization of the landowners or governing trustees. Any proposed development must have the consent of those with decision-making authority over the land.

I am exercising my legal rights under the RMA and Te Ture Whenua MÄ ori Act 1993 to declare this application invalid. We assert that this application is unlawful as we were not consulted, nor did we grant consent for this project. Our decision-making authority over our whenua has been disregarded, as we suspect is the case for many other landowners affected by this project.









While we recognize that legal redress is available to us, this is an unnecessary and unfair burden given that the RMA is designed to protect landowners and ensure their sovereignty (tino rangatiratanga) over their whenua.

The RMA clearly emphasizes the need for consultation with affected parties, including MÄ ori landowners, in matters involving MÄ ori land. The failure to appropriately consult us as landowners undermines the integrity of this application and exposes it to legal challenge.

We request that this application be reconsidered and rejected on the grounds that it fails to meet the legal and consultation requirements outlined above.

Safety risk. Isolation and response time of emergency services delay. A lot of the regions r staffed by volunteers so encroaching unnecessarily on their lives and time. 

The proposed trail risks disturbing significant w\(\text{A}\) hi tapu, where our t\(\text{A}\)«puna rest and where historical events took place.

These sites are not just landmarks; they are spiritually and culturally sacred, carrying the mauri of our ancestors.

Any disruption to these areas disrespects our tikanga and our duty as kaitiaki to uphold the sanctity of these places.

#### 2. Whenua â€" Kaitiakitanga Over Our Land

This trail will cross ancestral lands that hold deep historical and cultural significance to Te WhÄ nau a Harawaka and the wider WhÄ nau-Ä -Apanui iwi.

The development and increased foot traffic could lead to environmental degradation, erosion, and disruption to native flora and fauna.

There has been insufficient consultation with hapū and whÄ nau who are directly impacted, undermining our mana motuhake and tino rangatiratanga over our whenua.

#### 3. Moana – Safeguarding Our Waters

Our coastal environment is already under pressure from external influences; additional human activity through this trail may disturb marine ecosystems.

Increased access raises concerns about pollution, improper disposal of waste, and disruption to traditional kaimoana gathering practices.

The kaitiakitanga of our moana is a responsibility we take seriously, and we cannot allow projects that may harm its delicate balance.

#### Conclusion

This project poses a significant risk to our wA hi tapu, whenua, and moanaâ€"elements that are not just resources but the very essence of who we are as MÄ ori. Any proposal that disregards these must be challenged and stopped.



Motu Trails Charitable Trust (MTCT) is the governance and maintenance hub of Motu Trails, which sits under the umbrella of NgÄ Haerenga, Great Rides of New Zealand. Motu Trails includes over 30km of off-road trail.

At MTCT we submit three comments about the Te Ara Tipuna proposal.

First, it would appear from the TAT proposal document that the Dunes Trail to Opotiki is proposed as part of the TAT route. While the TAT stage one proposal is stated as for walking-only, it would appear that the long term goal of the TAT Charitable Trust is for a shared walking, cycling and horse trail. MTCT would under no circumstances support horses being allowed on the Dunes Trail. Horses and cyclists don't safely mix.

Second, MTCT would not support the TAT proposal unless it gains full support of every affected land owner(s), for the full distance.

Third, a general comment about maintenance. Trails are difficult and expensive to maintain, especially in a timely manner. We observe that a 500km+ trail would be an enormous maintenance proposition.



I, Maria Viseur strongly oppose the application for resource consent to the Gisborne District Council by Te Ara Tipuna Charitable Trust for the following reasons:

Here are the main points highlighted from my opposition:

- 1. Lack of Proper Consultation: The initial resource consent application for Te Ara Tipuna (TAT) Walkway should have been directed to the 40-plus Marae along the coast. TAT's scattered consultations are not considered just or fair for Ahi Kaa.
- 2. **Disrespect to Whanau and Hapu**: TAT failed to honour tikanga and provide Marae with the opportunity to approve

or reject the proposal, showing disrespect to the whānau and hapū.

- 3. **Role of Marae in Consent Process:** Marae should have facilitated the consent process, allowing whānau-hapū and landowners to express their views and reach a consensus.
- 4. Misuse of Charitable Trusts: Concerns over charitable trusts taking Ahi Kaa resources freely and rebranding them to Te Ara Tipuna (TAT) Charity to form a business and make profits for the trustees. A prime example of that is the Waipareira Trust (Charitable )who have recently come to light of accruing millions though government schemes enabling the trustees to be paid handsomely.

- 5. **Conditional Consent:** TAT Board's application should have been submitted to the Gisborne District Council only if Te Ahi Kaa/land owners gave consent.
- 6. **Exploitation Tactics**: Similar to major corporations, TAT's approach mirrors exploitative tactics, disregarding the mana of the whanau and promising benefits that often conceal or turn into harm.

- 7. **Employment and Tourism Concerns:** The proposal suggests employment opportunities and opening Marae to tourists, but this is seen as exploiting whanau for tourist benefits.
- 8. **Connection to Tipuna:** TAT's claim that the walkway will connect Ahi Kaa/land owners to their tīpuna is not convincing and is seen as trivializing their connection.
- 9. **Opposition to TAT Project:** The TAT project is divisive and disrespectful, and I understand that there is a strong opposition held by Te Ahi Kaa that further discussions must take place between all parties as this will impact our whenua, and our quiet space on the East Coast and East Cape.
- 10. **Ownership and Kaitiaki:** The whenua proposed for the walkway belongs to ancestors and descendants, and the kaitiaki do not agree to its use for tourists.
- 11. **Objection to Resource Consent Process**: Filing an objection feels like surrendering mana, but it's necessary to stand up and have our voices heard.

- 1. The first resource consent application for Te Ara Tipuna (TAT) Walkway should have been directed to the 40-plus Marae along the coast that uphold the mana of Ahi Kaa. TAT's scattered consultations along the coast cannot be regarded as a "just, or fair process for Ahi Kaa (home people)" or those who's whenua is about to be used without consultation. By failing to honour our tikanga and provide Marae with the opportunity to approve or reject this proposal, TAT has shown disrespect to the whānau and hapū who hold the mana of the whenua over which they propose to build a walkway for tourists with no personal consultation to discuss this issue. This disregard for our rights and responsibilities undermines the mana of the whenua and the authority of those who have long been the kaitiaki.
- 2. Marae should have facilitated the first consent process ensuring that whānau—hapu and landowners were given the respect in providing "time and safe space" to express our own personal views. The outcomes of these hui could then have been formally presented to the TAT Board as the official response from the hapū regarding the consent application. This way it could have allowed our own "voices" in a hui to come to our own consensus. Not to be bullied in another, "land grab opportunity under a so-called charity!" Charity for whom? Certainly not for our Ahi Kaa around the coast! What I know about "a charity" is they have their own tax-free entity with so called trustees who make decisions and command Government revenue. Also taking Ahi Kaa and land owners

resources and rebranding them under a charity. For example, one only has to look at what happened to the Charitable Waipareira Trust -

https://www.youtube.com/watch?v=giM2sNRkPbg. I believe here is a repeat for personal gains, thinly disguised by the trustees of the **Te Ara Tipuna Charitable Trust.** 

- 3. If and ONLY if Te Ahi Kaa/land owners gave consent to proceed, then should TAT Board's application have then been submitted to the Gisborne District Council for approval. What has been done at this time is not acceptable, especially that my own ancestors and our whenua are involved by the "land grab", so called charity track.
- 4. Instead, the mana of our whanau has been ignored and handed over to the Gisborne District Council to decide whether this kaupapa should progress. This mirrors the exploitative tactics used by major corporations to strip us of our tikanga and resources. They make sweeping statements about their plans for our minerals, our wai, and our whenua, promising that these actions will benefit everyone. They portray us as barriers to progress, accusing us of holding back development and employment, while claiming we lack vision for the future. When we know, the dollars are going into their own pockets, nothing charitable about people making personal gain out of others. They make lofty promises of wealth and prosperity flowing into our communities, yet

these narratives often conceal the lasting harm to our mana, our whenua, and our people. It is <u>not acceptable!</u> I do not consent to this approach!

- 5. We are already grappling with ongoing challenges to our rights, and now we are compelled to make a third submission to defend our rangatiratanga from being undermined by the actions of a select few. The TAT kaupapa seeks to plan, design, and speak over our whenua, much like corporations do with no regard of the mana of others. It promises increased employment opportunities, suggest that Marae should open their doors to tourists, and propose opening our remote communities to the world, which supposedly yearns to walk 500km of our coastline. Are these Trustees from this Charity Trust going to be there to make beds, cook and clean the Marae and make sure the tikanga of the Marae is upheld? I think not! Rebranding it as an opportunity to our whanau for them to be slaves, washing the feet of everybody else and waiting on them hand and foot and saying it's an opportunity for our people. Yes, and selling our culture too at the same time! In my eyes it is not acceptable!
- 6. They promote the idea that we as Ahi Kaa/land owners will somehow feel more connected to our tīpuna and our whenua through this walkway, yet they fail to explain how this connection is supposed to happen? It is seen more as a tourist venture to accommodate outsiders walking on our sacred whenua, using our minimal resources, because they

know we are kind, caring and giving people with a culture that gives to its manuhiri. So, they are actually planning to sell us out too! We as Ahi Kaa/land owners were not born yesterday and we experienced this stuff before and it's still in our DNA, from our ancestors. What is being said by TAT and proposed by them, does not wash with me! This proposed resource consent application is more likely to trivialize our connection, our whakapapa, and our deep love for our whenua and independence as whenua owners.

- 7. The TAT project is divisive and disrespectful, and we neither want, nor agree to any discussion about our whenua being led by the TAT Board or any local government agency. It is hypocritical to invoke the trail of our tīpuna while following the pathways (processes) of those who sought to strip us of our rights.
- 8. It is not Te Ara Tipuna whenua that they are proposing for the Walkway. It belongs to many of our tipuna who have passed it down to decedents. I am one, and I do not agree that the whenua of whom I am a kaitiaki of, is taken and used as a walkway for tourist! My ancestors say "No! We have been tricked time and time again!"
- 9. I am loathing that I am having to file an objection to the resource consent process, as doing so feels like surrendering the mana of our whenua to the TAT project and the council like they have all the authority to do so. However, when I think of my ancestors and the harm that was caused to them

by corporations, we need to stand up and have our own voice heard now!

Thank you for reading my Resource Consent Application – I Maria Huia Viseur, again reiterate that I do <u>not</u> consent to this application led by Te Ara Tipuna Charitable Trust for resource consent to the Gisborne District Council to construct, operate and maintain a recreational pathway, 'Te Ara Tipuna', around Tairawhiti from Gisborne to Ōpōtiki. I am a land owner with my son and my brother's whenua is also on that map for the walk way.

The consultation process has not been followed correctly and needs to go back to Te Ahi Kaa – the home people of the whenua, all the Marae whanau, the whenua owners including private owners. No half measures should be accepted!

- 3. How far apart are the wharepaku going to be situated? You'd have to have hundreds of them otherwise people will go wherever and god help those whanau who witness the mess left behind, which has been an issue with the Te Araroa trail. And who's going to clean them? Locals? Really?
- 4 What about the rubbish?
- 5. What happens when people decide they don't want to walk/ride anymore? There are no Ubers or taxis there. So are locals going to be expected to look after them?
- 6. What happens if the trails get blocked due to a weather event? Who's expected to look after them? Local marae who don't want this trail anyway.
- 7. Like the Te Araroa trail, food and accommodation can be difficult to get and this area would be worse because of the isolation. Don't expect the marae to supply kai because it's not going to happen.
- 8. Our whanau are struggling. 
