## Minutes

### Welcome and housekeeping

1. The hui commenced with a karakia at 9:35 AM. The Chair welcomed the Group and noted apologies.
2. The Chair led the discussion on the draft Hui 6 minutes. The Group requested for the following changes to be made:
  - 2.1. **Appendix 1: Outstanding and Scheduled Waterbodies** – correction of spelling errors: Te Rawheoro Marae (not Te Rawheora), Kaiaua Stream (not Kaiiau Stream), Waitakeo Stream (not Waitateo Stream)
  - 2.2. **Remove Appendix 2 and corresponding item 15** – the raw information in Appendix 2 have been processed and noted in the briefing paper 'Draft Actions for Action Plan'.
3. The Group accepted the changes to the draft Hui 6 minutes for finalisation.

### Session

#### Recap

4. Staff recapped the Group's progress through the National Objectives Framework (NOF) process.
5. Staff provided an update on next steps in the forestry conversation since the last forestry hui session on 18 September 2024. Staff informed that 2025 will look to focus on implementation of Land Overlay 3B and the Transition Guide developed by the Transition Advisory Group (TAG), with pilots for implementation in catchments like the Ūawa catchment. Staff highlighted that both forestry and farmlands are on the radar for implementation in 2025.
6. Members raised their concerns around the scope of works of the Large Woody Debris (LWD) programme, particularly the work done to date and the level of communications between the programme team and the affected parties (iwi, forestry industry, farmers, landowners). The Group expressed their keenness for open conversations and working collaboratively – which is not the current process undertaken by the programme team.
  - 6.1. Staff responded that they would bring a briefing paper with information at the next hui.
7. A member shared their concerns with emergency works not compliant with the direction set out in the Tairāwhiti Resource Management Plan (TRMP) nor the Resource Management Act (RMA).

- 7.1. Staff explained that emergency works are undertaken under the Civil Defence Emergency Management (CDEM) Act – which overrides the RMA when there is an emergency. Staff responded that they would bring a briefing paper to the next hui, addressing how certain activities under emergency works should be managed in compliance with the purposes of the RMA and the TRMP.
8. Staff asked the Group to email through their feedback on the briefing paper **'Updated Vision, Values, Environmental Outcomes and Attributes'**.

### **Water Quantity**

9. Staff noted that the current largest water uses in the Ūawa catchment are for: stock drinking water, residential use, and irrigation (only 1 consent). Based on staff knowledge, the Mangaheia River is fully allocated and may be overallocated. There is some water available in the Hikuwai River, noting that the river is tidal until as upstream as the Mangatokerau River. Across the catchment there are other small springs. There is a small freshwater aquifer (around Tolaga Bay township) and a larger saline aquifer (not suitable for drinking or irrigation).
10. The current methodology of setting the appropriate minimum/environmental flow is based on hydrology. There is an opportunity to identify the species to be used to set the minimum flow. Tuna (specifically longfin eel) was suggested for the species to be used to set the minimum flows in the Ūawa catchment.
11. The Group discussed what should be the priorities for freshwater use in the Ūawa catchment. In summary, in no particular order, the Group suggested:
  - 11.1. Stock water reticulation
  - 11.2. Allocation to include consideration of self-sufficiency (e.g. water storage tank on-site)
  - 11.3. That the small freshwater aquifer should be prioritised for domestic use
  - 11.4. Firefighting water
  - 11.5. Road works (e.g. tar seal the roads)
  - 11.6. Implementing principle of reciprocity – financial/environmental contribution in exchange for water takes
  - 11.7. Designated and known sites for drinking water takes (if not reticulated)
  - 11.8. Commercial uses (e.g. laundromat).

### **Action plans**

12. The Group discussed the draft actions in the briefing paper 'Draft Actions for Action Plan'. Staff explained the columns in the table, where the actions have been grouped into four headings:
  - 12.1. Cross catchment
  - 12.2. Farming areas and rural communities
  - 12.3. Forestry areas
  - 12.4. Settlement areas.
13. Initial roundtable identification of actions that members supported were raised. Staff asked the Group to email their feedback to form the draft catchment plan.

## **Closing, next steps**

14. For the next hui, staff will provide briefing papers identified in Tasks U-T11 to U-T13. Other items on the agenda include a report back on the findings of the economic model, and discussion on the draft catchment plan.
15. The hui closed at 12:33 PM with a karakia and a shared lunch. Hui 8 is scheduled for 27 February 2025.
